Engagement from Criteo to reduce administrative delays and increase invoice treatment quality

The purpose of this invoice charter is to present a few rules that will facilitate administrative exchanges between Criteo and its suppliers in order to secure and speed up the invoice payment process.

#### 1. When to send the invoice?

The invoice should be sent to Criteo with a maximum delay of 48 hours after the invoice date.

# 2. What information to put on the invoice?

Beyond all legal obligations, all invoices should at least contain the following information, otherwise it will be returned to you and we will not be able to process it in a timely manner.

- · Correct Invoiced entity
- Correct Invoiced entity address
- Correct description of the period to which the invoice is related

# 3. How to present the invoice?

As we are now using scanners in order to speed up our invoice processing, we would like to ask you to follow these rules :

- The invoice should not contain any staples
- The invoice should not be double-sided

Also, all invoices should be presented on Header Letter with information related to your company (company name, company address, bank details...)

#### 4. Where to send your invoice?

We request that you send us only one copy of the invoice either by e-mail (preferred method) or by paper.

Depending on the entity you are invoicing, please send your invoice to the appropriate address as follows:
